#### **Background & Purpose**

Changes in criminal landscape induced by the COVID-19 Pandemic:

In the midst of the COVID-19 Pandemic that has adversely affected every jurisdiction across the world, this seminar aims to bring together experts in the field to address an urgent need to predict and counteract the changing trends of crime.
